Regular Board Meeting Minutes January 21, 2021

1. Call Meeting to Order

The Maple Valley Fire and Life Safety Board of Fire Commissioners Meeting was called to order by Board Chairperson Craig Hooper at 6:03 p.m. In attendance were Commissioners Ben Hayman, Camille Walls, and Chris Bodlovic; Deputy Chief Mark Jones, Budget & Accounting Manager Lavina Brennecke, Business Analyst Soniya Moon, Local 1747 Union President PJ Knowles, and District Secretary Jessica Steward.

PSRFA Status Update:

- Elections were held for the 2021 Board Chairperson (Toni Troutner) and Vice Chairperson/CAPC representative (Allan Barrie).
- A CRR Week Proclamation was passed for the third week of January each year.

- The RFA purchased a small parcel of land adjacent to Station 78 to prevent future access issues.
- An overview of the HOO report was given with the new sections specific to each contract city.
- Working closely with Public Health and King County EMS to find a solution on community wide vaccinations. An amendment will be drafted to the existing contract for mobile team vaccinations, to serve long term care facilities. A mobile team deployed today. Half of the Auburn testing site lanes will be converted to vaccination stations starting February 1st.
- The city is negotiating with King County to host a community vaccination site at the ShoWare Center.

Financial Report: Budget & Accounting Manager Brennecke shared the Preliminary Year End Position document for 2020 with the Board. Taking inventory of KCFD #43 will be the first step in the capital plan. A capital planning workshop will be scheduled in the next couple months.
