Correspondence:

- Save the Date Greater MV Community Center 3/15/2012: Chief Doerflinger informed the Board that the Greater MV Community Center is hosting the 8th Annual Benefit Breakfast at 7:00 am on March 15th.
- ► <u>LERA 4/26-4/27/2012</u>: Chief Doerflinger reported that he and the union e-board have attended this conference in the past and highly recommends attending this year.
- Thank You Emergency Preparedness Class: A Thank You card was provided to Public Educator Janine Johnson for teaching an Emergency Preparedness Class.
- ➤ Invite to Multi-Care Emergency Department Grand Opening (not on agenda) 3/14/2012: Chief Doerflinger informed the Board that the grand opening is scheduled for March 14th 5:30 8:00 pm.

Meetings:

- King County Fire Chiefs 2/15/2012: Chief Doerflinger attended this meeting and informed the Board that the KC Chiefs have finished their pilot program and we will be preparing an Interlocal Agreement with King County to begin doing permitted inspections in Unincorporated King County within our district.
- Long Range Planning 2/16/2012: Chief Doerflinger reported that the Long Range Planning Committee met today and will be meeting again to review the updates to the Capital Improvement Project List on March 14th and will have the list to adopt at the Board Meeting March 15th. Commissioner Scott commented that all mission critical items had been addressed. Deputy Chief Cowan reported that this bond will need to fund capital needs through 2015, when we should be in a position to run another bond.
